- 2 The Financial results have been prepared in accordance with Indian Accounting Standards ('IND AS') as prescribed under section 133 of Companies Act, 2013 read with Rule 3 of the Companies (Indian Accounting Standards) Rules, 2015 and relevant ammendment thereunder.
- 3 Segment Reporting as defined in Ind-AS 108 is not applicable, since the company does not have any operating Income.
- 4 Comparative figures have been rearranged/regrouped wherever necessary.
- 5 The Company has considered possible effects that result from the Covid-19 pandemic in preparation of these standalone financial results. The impact of Covid-19 pandemic, including the current situation, may be different from that estimated as at the date of approval of these standalone financial results.
- 6 The Parliament of India has approved the Code on Social Security, 2020 (the Code), which may impact the contributions by the Company towards provident fund, gratuity and ESIC. The Ministry of Labour and Employment has released draft rules for the Code on November 13, 2020. Final rules are yet to be notified. The Company will assess the impact of the Code when it comes into effect and will record related impact, if any.
- 7 The figures for the quarter ended March 31, 2021, are the balancing figures between audited figures in respect of the full financial year and the published year to-date figures up to the third quarter of the respective financial year.
